- (2) William Clarke of Loaning, Witton Gilbert parish, Co Durham

  Lease and release of lands lying near the River Browney, within the parish of Witton

Gilbert, Co Durham, containing 36 acres, 2 roods and 18 perches plantation measure.

(1) has received 5s from (2).

- (1) William Clarke of Loaning, Witton Gilbert, Co Durham
- (2) William and Henry Richardson of North Shields, Northumberland, and George Richardson of the town and county of Newcastle upon Tyne

Mortgage by lease and release of lands near the River Browney containing 36 acres, 2 roods and 16 perches, plantation measure. (1) has received 5s. £900 is lent to (1), with repayment due 11 May 1824, and interest at £5% *per annum*.

Sale for £37 received by (1) from (2) of a plot of ground in Easington parish, Co Durham. The plot contains 17 feet in front from north to south, 39 feet in depth from east to west, and totals 73 and 2/3 yards square. Refers to a previous indenture of grant and conveyance on 23 May 1860 whereby George Cockburn gained use of the land. Parchment, 1m

Lease for 21 years of two parcels of ground with dwelling houses and other erections thereon at East Rainton, Co Durham, indicated in red on an included plan. The lease begins on 20 November, and rent is due annually by even and equal portions on the Feasts of Saint Martin and Pentecost at the sum of 1s 6d. With £9 7s 6d paid as consideration.

### Howlett Hall, Chester-le-Street

- (2) Henry and Philip Nairn of the borough and county of Newcastle upon Tyne Refers to a previous lease and release of 20 and 21 March 1837 whereby Brown was given that land whereon he has erected a dwelling house at Howlett Hall, Chester-le-Street, containing by estimation 7 yards in the front from east to west, and extending 14 yards backwards or thereabouts from north to south. (1) by this deed directs and appoints that this land be conveyed to (2) to whom he is now indebted for goods sold and delivered to the value of £45, and an agreement for them to advance him a further £45. Interest on this loan is calculated at a rate of 5% per annum. The total amount of principal monies to be recoverable under this security is not to exceed £200. Parchment, 3m

Transfer of mortgage, referring to three previous indentures involving the respective principal sums of £335 6s 4d, £300 and £965, which are still owing, but all interest has been paid to date. (3) have agreed to paid the first two sums to (1), and to lend (2) a further £2,999 13s 8d, with interest charged at £4 15% per annum, and repayments due on 20 June and 20 December every year. Lands involved are: Low Pasture containing 13 acres, 3 roods, 20 perches, Meadowfield containing 9 acres, 2 roods, 5 perches, Westfield containing 7 acres and 16 perches, Littlefield containing 4 acres, 2 roods, 12 perches and a stone quarry containing 2 acres and 7 perches as well as waste ground that is now used as a road. These are mortgaged by (2) to secure the total sum of £4,600. A map of the property is attached.

- (2) Edward Hall of Newcastle upon Tyne, gent, and Joseph John Wright of Sunderland, gent

Deed of Covenants. In consideration for £1,250 paid to (1) by (2), (1) surrenders the use of all that parcel of ground situate in Bishopwearmouth in a certain new street intended to be called Hudson Street, containing in the front or west part from north to south 63 yards and 1 foot, and on the east 59 yards and 1 foot, and in breadth from west to east at the south end, 29 yards and 2 feet, and at the north end 24 yards 1 foot and 6 inches. This land is surrendered together with the malting, 7 dwelling houses and all other erections or buildings, subject to an annual rent of £13 6s, with interest of £5 per centum per annum.

## Stanhope

NES/8/1 23 March 1852

- (1) John Byers, Westgate, Stanhope parish, Co Durham, yeoman
- (2) John Vickers of Newcastle upon Tyne, grocer

John Byers is indebted to John Vickers in the sum of £200, and as security for the loan, and in consideration of 5s paid to Byers by Vickers, is mortgaging those lands known as Shullingford, parish of Stanhope, consisting of the East Field containing 1 acre, 3 roods, and a parcel of land called the Rushy pasture containing 4½ acres, as well as all that leasehold tenement called High House, parish of Stanhope, and all those 5 parcels of ground containing together by estimation 12 acres, 3 roods and 13 perches. Interest at £5 per centum per annum which is subject to two previous mortgages for £400 and £330 and interest.

Admission in the Durham City court of Richard Matthew, of Boldon watermill, miller, as eldest brother and heir of the late William Matthew of South Shields, gent, to a cottage in the Dypes, abuttments detailed.

Admission in the Durham City court of Richard Matthew, of Bowdon watermill, miller, as eldest brother and heir of the late William Matthew of South Shields, gent, to a fourth part of a husbandry in the Upper Field, Boldon.

Copy surrender in the Durham City court by Thomas Atkinson, late of Harton now of West Boldon, gent, son and heir of the late Robert Atkinson the younger, of that field or close lying in and being part of certain lands situate in East Boldon called the Upp Field alias Little Dypes, containing 1¾ acres, and the admission of Richard Matthew of Bowdon watermill, miller.

NES/9/4 9 September 1799

Surrender in the Durham City court by William Matthew of East Boldon, yeoman, grandson and heir of the late Richard Matthew, of a watermill and windmill in Boldon, and admission of Richard Matthew of Boldon watermill, miller, the heir and eldest brother of William Matthew of East Boldon, now deceased.

Copy of 3 admissions in the Durham City court of Edward Matthew of Houghton-le-Spring, surgeon and apothecary, only brother and heir of Richard Matthew, to three parcels of land that he has inherited from his deceased brother in Boldon.

Copies of 3 surrenders and defeasances in trust in the Durham City court by Edward Matthew of 3 parcels of land at Boldon to the use of Peter Austin of Monkwearmouth, earthenware manufacturer, and William Austin of Hylton Ferry, earthenware manufacturer. 3 items, parchment, 1m each

NES/9/7 15 December 1838

Copy surrender and defeasance for securing £500 and interest, to the use of Thomas Griffith and his sequels, subject nevertheless to a yearly sum of £20, which if not paid, he is owed the fee of £500, with interest calculated at a rate of £5 per centum per annum. Parchment, 1m

- (1) Ann Matthew, of Easington Lane, Co Durham, widow and devisee for life under the last will and testament of the late Edward Matthew the elder of Houghton le Spring, surgeon
- (2) Edward Mathew the younger of Easington Lane, chemist and grocer, only son of the late Edward Matthew
- (3) Jane and Mary Ann Mathew of Easington Lane, daughters of the late Edward Matthew
- (4) Thomas Griffith of Durham City, gent

Deed of Covenants. Refers to a previous indenture regarding the Upp field. £500 has been paid to Ann and Edward Matthew by Thomas Griffith, and in consideration of this sum, interest at the rate of £5 per centum per annum, and subject to repayment due on 15 June 1839.

Copy surrender and defeasance, by Thomas Griffith of the North Bailey, Durham City, gent, to Henry Rounthwaite of Sunderland, broker, referring to that parcel of land called Curley Crook, in the township of East Bolden, containing 8 acres. Surrender is made in consideration of the sum of £440 paid by Henry Rounthwaite to Edward Matthew for the purchase of these premises free from encumbrances.

- (2) Robert Coltman Clephan and Dietrich Meno Leopold Wiencke both of Newcastle upon Tyne

Mortgage, refers to previous mortgage for £1,500 plus interest of £5 per centum per annum, remaining unpaid. The mortgagees have agreed to pay the mortgager £520 out of their partnership monies having the repayment with interest secured in the manner hereinafter expressed. Repayment is due on 1 January, with interest remaining at £5 per centum per annum. Hereby conveyed unto the mortgagees is all that parcel of ground near the village of Hartburn, parish of Stockton, measuring from north to south 141 feet, and from east to west at the southern end 69 feet and at the northern end 60 feet and 6 inches, containing in the whole 1,081 square yards. ### NES/11/1 15 November 1819

- (1) Thomas Barker of Edmondbyers, Co Durham, gent, and Jane Barker his wife
- (2) Hannah Barker and Margaret Barker, daughters of Thomas Barker, under the age of 21
- (3) John Proud of Edmondbyers, gent, and William Johnson of Millshields, Northumberland, farmer

Assignment, referring to a previous indenture whereby £1,200 was lent to a John Bell by Thomas Barker, and by this indenture the assignment of £1,000 and interest of this repayment to be put in trust as security for Hannah Barker and Margaret Barker, as well as an annuity of £10 to be paid to his wife after his death, is witnessed. Parchment, 3m
