### Introduction

Collection title: Ushaw Collection of Manuscripts: Volume III Reference code: GB-0298-UC/M3 Dates of creation: 1501-1789 Extent: 1 volume Repository: Ushaw College Library Language of material: Mostly English and Latin. The documents are in English unless otherwise stated in the item record.

### Contents

Volume III of the Ushaw Collection of Manuscripts covers a wide range of subjects relating to Catholic history, including: Pope Clement XIV's suppression of the Jesuits in 1773; the fate of the Jesuits in England; the Marriage Act and its implications for Catholics marrying in Protestant churches; the appointment of vicars apostolic, coadjutors and priests; other internal Catholic matters.

#### Previous custodial history

Volume III was compiled and bound in 1936 by the late Mgr Bernard Payne who was librarian at Ushaw from 1930 until 1977. Acquired at different times from many different sources.

Arrangement The sequence retains the original volume-number arrangement.

Open for consultation.
