Cawley's passport, signed by the British ambassador to Italy, Sir Augustus Berkeley Paget

LC/P1/2 10 August 1881

Letter from George Duthoit (Huddersfield) to T. Cawley: enclosing a cheque; thanking him for the wine; his shock at the failure to protect the remains of Pope Pius IX

LC/P1/3 10 August 1882

Letter from George Duthoit (Huddersfield) to T. Cawley: enclosing a half-yearly cheque; the debts of Cawley's brother

LC/P1/4 25 August 1882

Letter from George Duthoit (Huddersfield) to T. Cawley: asking Cawley not to tell his brother that Duthoit informed on him

LC/P1/5 16 January 1886

Letter from R.J. Warke (Halifax) to T. Cawley: informing Cawley that he is not eligible for the Yorkshire Brethren in his current post unless he becomes a priest in the diocese

Letter from T. Worthy (Halifax) to T. Cawley: asking him to sign the enclosed rules of the Yorkshire Brethren (not extant) and return them

Letter from T. Worthy (Halifax) to T. Cawley: asking him to send sample cases of port and claret

Letter from Bishop William Gordon (Leeds) to T. Cawley: there is no need for Cawley's incorporation as he already belongs to the Leeds diocese; wishing to receive news on the progress of his student at Lisbon College

Letter from T. Worthy (Halifax) to T. Cawley: Cawley has been unanimously elected to the Yorkshire Brethren; sending a form and rules for entering fund masses

Letter from T. Worthy (Halifax) to T. Cawley: thanking him for his gift of the wine; suggesting that Cawley's age should not affect Cawley's benefits from the Brethren Fund

Letter from T. Worthy (Halifax) to T. Cawley: a £10 cheque sent to the treasurer; his entitlement to full benefits

Letter from T. Worthy (Halifax) to T. Cawley: Glover's omission of Cawley's Christian name on the register; rules relating to prayers for benefactors' souls

Letter from J. Glover to T. Cawley: the recording of Cawley's name in the minutes; rules on the Pact Masses

Letter from Theresa Ryan (North Williamstown, Australia) to T. Cawley: asked Davies whether Duthoit appointed another trustee; hoping that Oweh Avison's money has not been lost

Letter from Theresa Ryan (North Williamstown, Australia) to T. Cawley: Piercy confirming that Mrs Duthoit is still a trustee for the Manchester Road property so she will reply to ask him to appoint Barlow and Emerson instead

Letter from Theresa Ryan (Tasmania) to T. Cawley: the death of her father causing her to sell the dairy and leave the Melbourne Mission to Seamen

Enclosures: letter from Haire, acting chaplain, to Ryan, with condolences and asking her to reconsider her resignation; letter from Mollison, secretary to the Mission, to Ryan, accepting her resignation and thanking her; and *Quarterly Jottings* (Victoria Missions to Seamen, Michaelmas, 1910)
