Accounts of the college's agents in London, mostly financial but with occasional references to other college matters and the Catholic Church in Portugal and elsewhere.

About the creator

The English College of SS. Peter and Paul at Lisbon (or, as it is more commonly known, Lisbon College) was founded by Pedro Coutinho in 1624 as a college for English students training for the priesthood and mission work in England. As a pontifical college it was awarded the same privileges and rights as other colleges centrally controlled by Rome. such as the English College in Rome, whose aim was the maintenance of the Catholic faith in England, Scotland and Ireland. The driving force behind the college in its early years was William Newman. Although he was never to become president, Newman founded the college from property entrusted by the estate of the late Nicholas Ashton, a Catholic chaplain in Lisbon. Initial progress was slow until the arrival of a group of English students and teachers from the English College at Douai in 1628. The first president, albeit briefly, was Archdeacon Joseph Haynes who died the following year. The reputation of the college as a centre of academic excellence and its relevance as an English institution in Lisbon attracted patronage from varied sources during the seventeenth century, including Pedro da Costa and Maria de Oliveira Leitoa who transferred important funds to the College in exchange for daily masses for their special intention. In 1679, Pope Innocent XI granted the College the privilege of being considered as a High Altar of Christ on the Cross. In spite of its wealthy benefactors and papal patronage, the college faced a number of challenges in the following centuries. In 1755, Lisbon was shaken by a terrible earthquake in which 20,000 people died and 60,000 houses and 60 palaces and convents were destroyed. The college suffered badly both in terms of the physical devastation of its buildings and the mental well-being of many of its students and superiors who, like most of the population of Lisbon, chose to live under tents in the gardens of the college rather than risk being inside in fear of another quake. The college suffered another setback when it was occupied by French forces during Napoleon's invasion of Portugal in 1807 and, just days before the second French invasion, the president decided to close the college down, with all students being sent to an Anglo-Portuguese school in England until the war ended in 1814. The college was finally closed in 1973. Since the passing of the Roman Catholic Relief Act in Britain in 1829, the college's raison d'etre had ceased to exist although it's high reputation as a teaching and training establishment enabled it to survive for another 144 years.

Accession details

Lisbon College closed in 1973 and this collection, along with the rest of the Lisbon Archive and Library, was transferred to Ushaw College by Mgr James Sullivan the following year.

Statement of account of John Sheppard, sent to Gerard Bernard, for Christmas 1768 - midsummer 1769

Includes a covering letter from Sheppard to Bernard: Butler's bankruptcy; his hopes that Daniel Arthur has not suffered from the failure of Dillon & Wise; money for Bissager 2f

Statement of account of John Sheppard, sent to Gerard Bernard, for midsummer - Christmas 1769

Includes a covering letter from Sheppard to Bernard: Walton to be made a bishop so J. Barnard will be given notice of a general meeting of the chapter; money for Crathorne 2f

Statement of account of John Sheppard, sent to Gerard Bernard, for Christmas 1769 - midsummer 1770

Includes a covering letter from Sheppard to Bernard: deaths of W. Grimallstone, John Philip Bates, Thomas Francis Hunt, Thomas Bennett, and John Hawarden; expecting to hear of Walton's elevation to bishop so a new dean will be elected 2f

Statement of account of John Sheppard, sent to Gerard Bernard, for midsummer - Christmas 1770

Includes a covering letter from Sheppard to Bernard: Chapter meeting; money for P. White from young Mr Butler of Pall Mall; Fisher of Stowley having two boys recommended by Bishop Petre who will pay their travel expenses 2f

Statement of account of John Sheppard, sent to Gerard Bernard, for Christmas 1770 - midsummer 1771

Includes a covering letter from Sheppard to Bernard: suggestions for obtaining money from the [?Chapter] and a squabble in the Chapter with the dean; Mr Blevin asking whether Bernard's brother is married

Statement of account of John Sheppard, sent to Gerard Bernard, for midsummer - Christmas 1771

Includes a covering letter from Sheppard to Bernard: Bernard's appeal for help sent to Challoner; money for White from young Butler

Includes a covering letter from Sheppard to Barnard: no boys to be sent to Rock; Talbot to get two masters from Douai; both Challoner and Talbot won't let Barnard leave; T. Lee, J. Simpson, and C. Metcalfe's baptismal certificate; Sheppard's attempts to get three or four students from Mr Kendal

Statement of account of John Sheppard, sent to James Barnard, for Christmas 1778 - midsummer 1779

Includes a covering letter from Sheppard to Barnard: F. Nicholson (on the triple trust), John Sumner and Charles Foothead to arrive soon (all from Sedgley Park); asking Barnard to write to Rome for dispensations for Caton and Webster; his fears for diplomatic relations between England and Portugal 2f

LC/A1/4/2/41 18 January 1780

Statement of account of John Sheppard, sent to James Barnard, for midsummer - Christmas 1779

Includes a covering letter from Sheppard to Barnard: Blount forwarding a letter to Rome; Sumner's complaints about the college; a Lancashire boy; Hornyold's death; Blount expecting to succeed Walton; Dean Kendall's poor health

Statement of account of John Sheppard, sent to James Barnard, for Christmas 1779 - midsummer 1780

Includes a covering letter from Sheppard to Barnard: settling Preston's account; wishing to get boys from St Omers; Barnard's wish for two masters of humanity; his opinion that Allen will not be much of a loss to the college; suggesting that he visits Kerswell as it is in a poor state

Statement of account of John Sheppard, sent to James Barnard, for midsummer - Christmas 1780

Includes a covering letter from Sheppard to Barnard: Challoner's death and his possible successor (Talbot) likely to be friendly to the college; a delay in getting a vice-president caused by Blount's resignation of Douai's presidency; plans of palaces from the king of Portugal; Bolton not wanting letters from Lee, a priest in Portugal 2f

Statement of account of John Sheppard, sent to James Barnard, for midsummer - Christmas 1781

Includes a covering letter from Sheppard to Barnard: Fryer to be vice-president and a young man also from Valladolid to be appointed as master of humanity; Blount recommending a boy from Douai; suggesting that Barnard returns to England to improve his health; Mrs Nichols, Mrs Myners, Mrs Lowe and Mrs Butt; money for Philip Browne; Mrs Maryman's fund

Statement of account of John Sheppard, sent to William Fryer, for Christmas 1782 - midsummer 1783

Includes a covering letter from Sheppard to Fryer: Hunloake's account settled with Barnard; Sheppard of Valladolid nominator to Sheppard's fund; debts of Brown and Dodd; Hurst a suitable Paris agent; a salary for masters and the possibility of a master being sent from Douai; his refusal to be an agent for Syon; asking who has succeeded Mrs Carter as abbess

Statement of account of John Sheppard, sent to William Fryer, for midsummer - Christmas 1783

Includes a covering letter from Sheppard to Fryer: Coghlan paid for books; £10 for Allen from Talbot; stock purchases, wishing to sell South Brent Farm; Paris rents not received; Mrs Woodbury; Kitchen may send a boy if qualified; the death of Bolton

Statement of account of John Sheppard, sent to William Fryer, for Christmas 1783 - midsummer 1784

Includes a covering letter from Sheppard to Fryer: Bordley wanting to send boys; Kitchen recommending a boy from the north; the inability to recover Billington and Nicholson's expenses; enquiring about Benjamin Smith who has entered the college on a triple trust 2f

Statement of account of John Sheppard, sent to William Fryer, for midsummer - Christmas 1784

Includes a covering letter from Sheppard to Fryer: hoping to get mathematical instruments soon; wishing to know the names of all the boys entering the college; thanking him for permission to borrow £300 from the Common Fund to finish the building; Carter recommending a boy for the college; money for Allen and V. Lolli; Miss Low's arrears 2f

Includes a covering letter from Sheppard to Fryer: Fryer likely to lose his advancement to Foothead and Dillon; awaiting Carter's reply on whether his nephew will fill a vacancy; Bordley's boy; lack of rents from Kerswell Farm; Hunloke's complaints on the last shipment of wine

Statement of account of John Sheppard, sent to William Fryer, for Christmas 1785 - midsummer 1786

Includes a covering letter from Sheppard to Fryer: land and stocks rising in value; Kerswell Farm rents are behind; students to be sent from Douai; his recommendation of a minimum age of 16 for entry into the college; Carter's nephew is ill so cannot come to Lisbon; the difficulties in recovering boys' travel expenses
